The Municipal Community Grants Program supports In-Kind Funding which refers to services or resources offered by the municipality (use of municipal venues, services, equipment, labor, etc) as valued by the <a href="Fees and Charges By-Law">Fees and Charges By-Law</a> that can help support the work of the applicant and reduces expenses of the work or initiative proposed.

## Maximum Grant Size: \$2,000 per year

Applicants can apply twice a year for In-Kind Funding during the Spring or Fall intakes unless they have received the maximum grant size during the Spring.

In-Kind Funding must be used between June 1st 2025 and May 31st 2026.
